

**Data Protection consent form**

New data protection rules apply from 25 May 2018 under the General Data Protection Regulation (GDPR). Chalfont Heights Roads Committee Limited has updated its Privacy Policy in line with these. To comply with the new rules, we need to re-confirm your consent over how we collect, store and process your data.

We would like your permission to collect and store specified and limited personal information about you, to enable us to communicate with you and keep you informed about the Estate, as set out in our Privacy Policy. These communications are usually emails about general Estate matters, or about planning applications and decisions. This consent form also applies to the Chalfont Heights Neighbourhood Watch scheme, which distributes to subscribers community alert messages from Thames Valley Police, and which abides by the same Privacy Policy under GDPR.
