of the

# FORTY SECOND ANNUAL GENERAL MEETING

Held at Chalfont Park Sports Club MONDAY 24TH FEBRUARY 1997 at 8.15pm

PRESENT:-

Messrs. J.H.Luya (Acting Chairman), J.S.C.Chandler, J.W.Williams, K.L.Morrison, R.W.Stewart, D.Bryan, D.A.Bates and Miss.G.A.Colligan (Secretary).

Apologies for absence from Messrs., H.M.McKeeman, I.R.Martin, T.M.Cooper and Dr. Hulme and Mrs. Hulme.

**MINUTES** 

Mr.J.Luya (Chairman) payed tribute to Mrs.Margaret Clifton, Secretary to the CHRC and a dedicated member of the Committee since 1979, who died on 19th October 1996.

The Minutes of the forty first Annual General Meeting, held on 19th February 1996, were confirmed and signed by the Chairman. Proposed by Mrs.V.C.Chandler and seconded by Mr.B.Allan

MATTERS ARISING

Mr.J.Luya made a personal statement to support, maintaining standards in our environment.

#### **COMMITTEE REPORT**

ROADS/GATES/SIGNS

Mr.K.Morrison confirmed that two of the five road surfaces on the estate have been completed in the road programme and that Woodside Hill, Lincoln Road and Ellis Avenue will be attended to.

Mr.Morrison highlighted that the increased annual road expenditure which was roughly £12,000 could not continue at this level.

Mr.B.Allan asked if the Committee were aware that Joiners Lane would be closed from Monday 10th March to Sunday 18th May to enable Three Valleys Water to lay new water pipes. As a result of this many residents expressed their concerns regarding additional traffic through the estate, particularly contractors and heavy goods vehicles.

Mr. Morrison explained that Three Valleys Water have been notified by the Committee, but it would prove difficult to prevent other car drivers taking a short cut through Chalfont Heights.

Mr.J.Cole(Deep Acre, Lincoln Road) suggested that the Committee investigate the possibility of compensation for damage to the roads due to increased traffic.

Mr.K.Morrison agreed to approach the contractors.

Mr.D.Brown (Hilltop) asked if the Committee had considered closing the Gates during commuter hours to prevent non-residents using the estate as a short cut when Joiners Lane is closed.

Mr.Luya pointed out that not all residents may want the gates to be closed and manning the gates would require organisation, and a substantial number of volunteers. Emergency vehicles may also need access. Mr.Williams will investigate our legal position regarding public right of way and report back.

It was decided that residents who would like to volunteer for the manning of the gates should contact the committee.

As requested by a resident of Lewis Lane, Mr.Luya said he would look at the possibility of a 'Lewis Lane' road sign for persons travelling down Chiltern Hill.

A resident of Winkers Close, Mr.Quilter, was concerned about the speed of traffic through the estate due to a low speed ramp. After some discussion Mr.Luya said that the ramp in question would be inspected. Both Mr.R.Kendall (Lewis Lane) and Mr.D.Green (Woodside Hill) suggested that a gap in the ramps would relieve drainage problems due to a build up of water in bad weather. This could be dangerous for cyclists but Mr.J.Luya said he would speak to the contractor and find out costing

#### TREES

Mr.Chandler (Trustee) reported that £2654 was spent on tree maintenance which was less than the previous year which amounted to £3725.

Mr. Chandler said that topping and replacement of trees will be reviewed in the Autumn as visibility of the trees improves during this season and replacement of trees would be carried out shortly.

TRUSTEES AND DEVELOPMENT

Mr. Chandler commented that relatively few requests for planning approval had been received since the end of December.

Mr. Chandler suggested that contractors carrying out work at weekends should be instructed not to operate machinery on Saturdays after 12 noon or at any time on Sundays.

Mr.Foster (Wyndsway, Woodside Hill) asked if any opinion had been given re: M25 service station behind Willow Tree Farm.

Mr.J.Luya said that the Committee would be able explore this matter when information is supplied.

#### ANNUAL REPORT

Mr.B.Allan raised the issue of £100 being donated to the Denham Airfield Environmental Federation and stated this was a precedent. After some discussion it was agreed that £100 would be donated to DAEF who are taking legal proceedings to reduce the noise level and disturbances from aircraft flying over the area. Proposed by Mr.B.Allan and seconded by Mr.R.Kendall.

#### FINANCE

Mr.J.Williams (Hon.Treasurer) circulated the accounts for the year ended 31st December 1996 and reported that the £6,000 deficit was due to increased road expenditure which Mr.Morrison discussed earlier in the meeting (see: ROADS).

Mr.R.Kendall asked the Hon.Treasurer to clarify what the Insurance covered. Mr.Williams explained that this is Public Liability Cover for accidents on the roads for up to one million pounds. Residents requested that the Committee should consider increasing the Insurance cover. Proposed by Mr.Kendall (Lewis Lane) and seconded by Mr.D.Bates (Bochym,Lewis Lane)

Mr.J.Williams (Hon.Treasurer) thanked our Honorary Auditors, Mr. Roy Solomon and Mr. Keith Quilter and it was agreed that they should continue. Proposed by Mrs.M.Reynolds and Seconded by Mr.J.Cole (Deep Acre, Lincoln Road)

#### SUBSCRIPTIONS

It was agreed, after discussion) that 1997 subscriptions will be:

Full Subscriptions - £45 Reduced Subscription - £41

Subscriptions not paid by 31st May will be increased by £10 to £55 and £51 respectively. This was proposed by Mr.Dunn and seconded by Mrs.J.Cassell (Half Acre Hill).

#### COMMITTEE

Mr.J.Luya (Chairman) reported that Mr.J.Williams will be resigning from his position as Hon.Treasurer to the CHRC. Mr.Ian Martin (Wyndyate, Lincoln Road) having agreed to join the Committee, will in due course, replace Mr.Williams as Hon.Treasurer.

Members of the Committee and residents of Chalfont Heights would like to thank Mr. Williams for his commitment and service to the Estate over the past 12 years.

The current Committee agree to stand for re-election, it was proposed by Mrs.B.Wickham and seconded by Mrs.Kendall and agreed that members of the Committee should be re-elected and that Miss.G.A.Colligan (Deep Acre) shall be elected as Secretary for the Committee.

On behalf of the residents of Chalfont Heights Mr.R.Kendall gave a vote of thanks to the Committee in recognition for their continuous work for the well being of the Estate.

#### ANY OTHER BUSINESS

A vote of thanks was given to the President of the Chalfont Park Sports Club.
